St Peter's Way westbound overnight closure

Please note that due to unforeseen circumstances, our previously communicated closure overnight on Monday 07th July has had to be re-planned on Tuesday 08th July, apologies for any inconvenience caused by this.

From **10pm – 5am, on Tuesday 08th July** the St Peter's Way Westbound carriageway will be closed between the M25 J11 and Guildford Road as shown on the below graphic.

During the closure, we will be moving our current lane closure to enable safe working room on the verge as opposed to the central reserve. From 5am on the Wednesday morning, the St Peter's Way westbound carriageway will **remain** running under 1 lane.

During the closure, a diversion will be in place via Chertsey using St Peter's Way eastbound, Chertsey Road, A317, Bell Bridge Road and Guildford Road.

Guildford Road overnight Closure

Part of our improvements scheme is to widen the northbound approach to the St Peter's Way roundabout (from Guildford Road). To carry out this work, we need to temporarily close a lane on the approach to the roundabout.

From **8pm – 5am on Wednesday 09th July**, the below section of Guildford Road (between Ottershaw, and St Peter's Way) will be closed in both directions while we install the temporary vehicle barrier.



During the above closures, a signed diversion will be in place for northbound traffic (Towards Chertsey) via Addlestone, by following Murray Road, Spinney Hill, Church Road, the A318, Chertsey Road and St Peter's Way.

For southbound traffic (towards Ottershaw) please join St Peters Way eastbound, Chertsey Road, the A318, Church Road, Spinney Hill and Murray Road.

When planning these closures, we liaised directly with the emergency services to ensure as little disruption as possible is caused to these vital services.

We would like to take this opportunity to thank you all for your patience and understanding while we carry out these improvements works to this vital stretch of road and apologise for any inconvenience caused.
