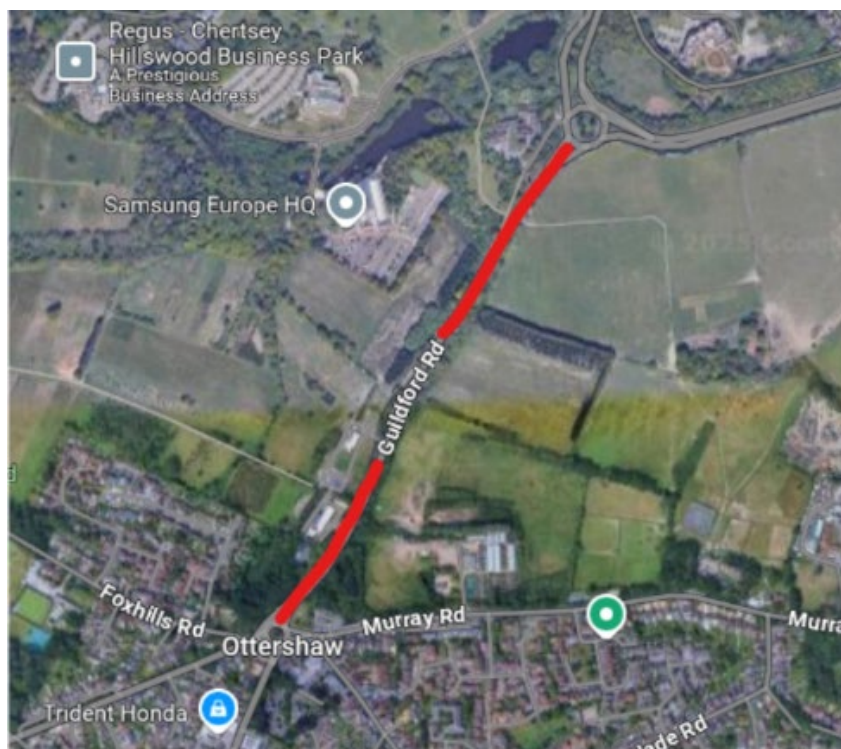

### **Guildford Road Northbound Closure Between Ottershaw and St Peters Way**

Guildford Road northbound between the Ottershaw / Otter roundabout and the St Peter's Way roundabout will be closed for 1 week while we carry out essential utility diversions beneath the ground, these utilities were previously undiscovered, and their movements are a necessity for us to continue our work. The southbound section of Guildford Road will remain open.

The road will close at **1am Saturday 30<sup>th</sup> August and will remain closed until 23:30 Friday 5<sup>th</sup> September**, please note that this closure will be active for 24 hours a day.

During the closure, a signed diversion will be in place via Murray Road/ B3121, Chertsey Road and St Peter's Way westbound.

### **Guildford Road Northbound Closure Between St Peter's Way and St Peter's Hospital**

We are currently carrying out improvements to the drainage around St Peters Roundabout, and the nearby footpath towards St Peter's Hospital. In order to continue this work, we need to move the barriers that segregate our works from the travelling public.

To move the barriers, we need to close the below section of Guildford Road northbound from **8pm on Friday 29<sup>th</sup> August – 1am Saturday 30<sup>th</sup> August.**

During the closure, no access from the St Peter's roundabout to St Peters Hospital will be available.

A signed diversion will be in place via Chertsey using St Peter's Way eastbound, Chertsey Road, the A317, Bell Bridge Road, and returning to Guildford Road.



We would like to take this opportunity to thank you all for your patience and understanding while we carry out these improvements works to this vital stretch of road and apologise for any inconvenience caused.
